### **GUIDELINES For Online Registration for Admission to B.Ed & M.Ed**

#### **(Academic Session 2023-25)**

The University of Jammu invites online applications for admission to the **B.Ed & M.Ed** Programmes of the University of Jammu **Main Campus/Offsite Campuses/ Private Affiliated Colleges** for the Academic Session 2023-24. All the desirous candidates (CUET & Non CUET) seeking admission to any of the above programmes, are required to fill Online Admission Form as per given schedule:

1.	Commencement of the filling of the Online Admission Form on the University Admission website	<b>23/10/2023</b>
2.	Last date for the filling of the Online Admission Form (without late fee)	<b>28/10/2023</b>
3.	Last date for the filling of the Online Admission Form on the website with late fee <b>through online PAYMENT mode only</b> (Debit/Credit Card/Net Banking etc.)	<b>30/10/2023</b>
4.	Onetime <b>EDIT OPTION</b> shall be extended to all the applicants to make any correction/s or upload any left out documents in their online Application forms. No request/s for any correction shall be entertained thereafter.	<b>31/10/2023 &amp; 01/11/2023</b>

B.Ed	A candidate to be eligible for admission to the B.Ed must have passed in the final Semester / year of the qualifying Bachelor's Degree Examination of 10+2+3 pattern with <b>at least 50% marks (45% for SC/ST Candidates)</b> and/or Master's Degree in Sciences/ Social Sciences/ Humanity, Bachelor's in Engineering or Technology with specialization in Science and Mathematics, from a recognised University/ Institution with <b>at-least 55% of the aggregate marks or any other qualification equivalent thereto and have appeared in the CUET-PG-23 Paper COQP3</b>	2660	200
M.Ed	A candidate to be eligible for admission to the M.Ed, must have passed in the final Semester/ year of the qualifying degree examination i.e. B.Ed, from a recognized University/ Institution with <b>at-least 50% of the aggregate marks (45% for the SC / ST candidates) and have Appeared in the CUET-PG-23 Paper COQP15</b>	500	130

- 1) Admissions shall be done on the basis of the marks obtained in the Common University Entrance Test (CUET-PG-2023) conducted by National Testing Agency (NTA) and Campus/College Preferences given by the candidates in the online admission form.**
- In case, seats remain vacant after exhausting the entire merit list of CUET-PG-23 the same will be filled up by the NON-CUET-PG applicants on the basis of the Academic Merit of the Qualifying Examination. Application for Admission shall be submitted online as per the dates specified in the Admission Notification.
- All the admissions shall be PROVISIONAL till such time the same are verified/ regularized by the University. No document/ certificate shall be accepted by the Nodal Department/ College after the last date. Admission shall be made through online Counseling on the basis of the preferences/choices given by the candidate on the online admission form.**
- Filling up of the Online Admission Form is mandatory and pre-requisite for Admission. The Candidates are required to fill the same carefully as per the Statutes. The University will not be responsible for any mistake/ lapse on the part of the Candidate while filling up of the Online Admission Form.
- In case of B.Ed 75% of the total allocated seats are reserved for Domicile candidates and 25% for Non-Domicile candidates for each affiliated College.**
- FEE & MODE OF PAYMENT:-**Registration Fee, for admission, to be charged from each applicant and mode of payment is online only (Net Banking / Credit/Debit Card etc.) The applicant can check his/her status of payment after login to his/her account on the admission portal through APPLICANT LOGIN. **In case of M.Ed** the candidate desirous to be considered for SELF-FINANCING seat has to pay an additional fee of Rs.730/- which has to be paid at the time of filling up of the Admission Form.

**A candidate who does not opt for the Self Financing Seat/s at the time of the filling up of the Online Admission Form along with the requisite fee will not be considered for Admission under the Self Financing Seat/s at later stage.**

- 7) **No 'UNDER PROCESS CERTIFICATE' will be entertained under any circumstances for Admission under any Category.**
- 8) **CHECK LIST for applying online: (Scanned Documents to be uploaded)**
  - a) Date of Birth Certificate / 10<sup>th</sup> Class Certificate.
  - b) All Mark Sheets of qualifying examination in single pdf file only.
  - c) Category Certificate/s (if applicable).
  - d) Achievement Categories Certificates (if applicable) in single pdf file only(For M.Ed only).
  - e) Domicile Certificate.
  - f) **Self-Declaration (UNDERTAKING-Annexure "A")**.
- 9) **All the applicants applying for admission have to upload the SELF ATTESTED Declaration/ Undertaking as per Annexure-A. If the applicant is admitted in a particular programme he/she has to submit the said Undertaking on e-stamp/affidavit duly attested by the First Class Magistrate / Notary.**
- 10) For M.Ed the applicants under Reserved/Achievement Categories has to upload Self Attested copy of the Domicile Certificate along with Reserved/Achievement Category Certificate/s issued by the competent authority as per **Annexure-B**. Certificates of Achievement Categories (i.e. **Sports, Cultural & Literary Activities, NCC, NSS and Bharat Scouts and Guides**) are required to be upload for evaluation. Achievement Certificate/s not uploaded online at the time of filling of online admission form will not be considered for evaluation at later stage.
- 11) A Candidate selected for Admission under any Reserved/ Achievement Category has to keep ready the Original and Self Attested Copies of the Domicile Certificate as well as the other relevant Reserved Category Certificate/s as required and as issued by the Competent Authority. Such a Candidate is required to submit these certificates to the concerned Department/ Nodal Department for verification on the date as notified for the purpose. The admission of such candidate is subject to verification of the ORIGINAL certificates by the Members of the Admission Committee of the concerned Department/ Nodal Department.
- 12) In respect of the Admissions to the Campuses/Affiliated Colleges, the Nodal Department/s will charge the University fee and other fee, as the case may be, shall be charged directly by the respective Campus/ Institute / College.
- 13) The Admission of a Candidate supplying incorrect/factually wrong information in the Online Admission Form will not be considered for admission and is liable to be cancelled at any stage.
- 14) The Applicants after successful completion of registration of the online admission form are advised to keep a print out of his/her Application, copy of fee receipt for any future reference.
- 15) **No separate intimation for Counselling or Admission shall be sent individually to the candidates. Candidates are advised to be in continuous touch with the University website & their Email for latest information w.r.t. admission, eligibility and other details.**
- 16) **For further details / eligibility candidates are advices to refer Admission Brochure/ Statutes available on the Admission Portal.**
